Donation Will Help Support Dental Education in Oregon

The ODS Companies Donates \$250,000 to Establish Scholarship Fund

Thanks to a generous donation from The ODS Companies (ODS), the Oregon Dental Foundation (ODF) is pleased to announce the formation of a scholarship fund to help advance dental education throughout Oregon. The \$250,000 donation from ODS will be matched by the ODF to establish a \$500,000 scholarship fund.

The ODF intends to distribute \$25,000 per year from the fund to individuals wishing to pursue studies in any aspect of dentistry, including dental assisting and hygiene. Scholarships will be distributed in late 2006; specific qualifying criteria have yet to be established.

“One of our main goals as an organization is to ensure that everyone in Oregon has access to adequate dental care,” said Dr. Ken Berg, ODF Chairman. “Without a steady flow of young adults entering the dental profession every year, that will not happen. By establishing this scholarship, we hope to encourage more students to pursue a career in dentistry.”

Founded by the Oregon Dental Association in 1982, the ODF is governed by a volunteer board of directors made up of dentists and members of the public at large. The ODF supports community projects such as not-for-profit clinics and other facilities that provide dental care to the disadvantaged, along with numerous dental education and research ventures. In 2005, the ODF distributed approximately \$75,000 in grant funding to more than 20 organizations.

According to Robert Gootee, ODS President and Chief Executive Officer, the donation was a natural fit for ODS, which has supported the ODF for many years. “ODS has partnered with Oregon dentists for more than 50 years. During that time we’ve become deeply connected with dentistry, and we believe this scholarship will help strengthen the future of the profession we so strongly believe in,” Gootee said.

“Furthermore, we hope this commitment to the Oregon Dental Foundation will help demonstrate to the community the excellent

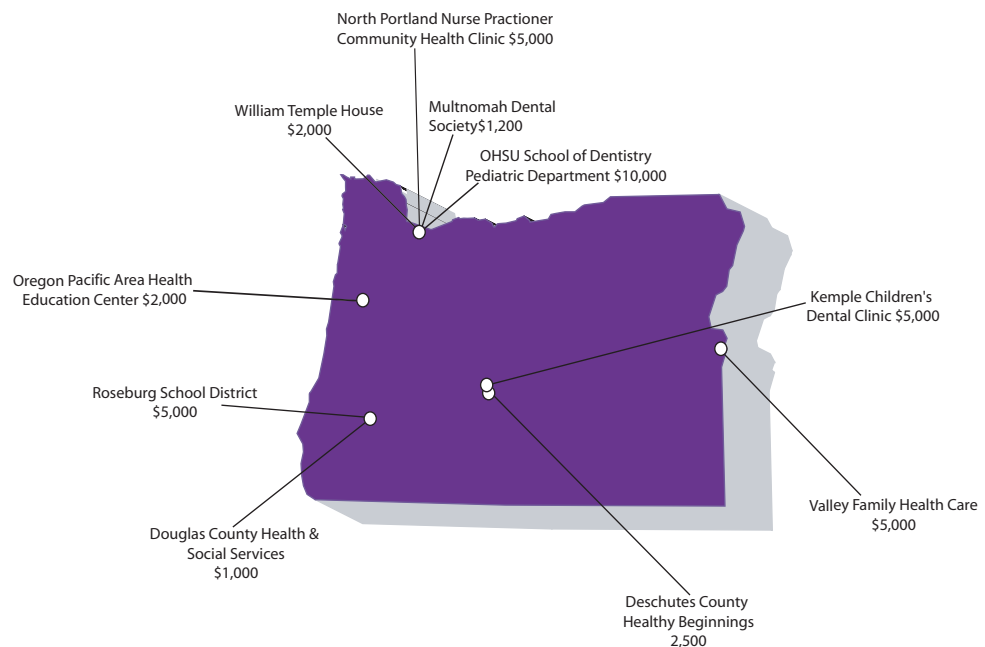

The Oregon Dental Foundation awarded \$38,700 in grants to various programs and organizations throughout Oregon during its fall 2005 grant cycle. "Once again, choosing the recipients was a difficult decision for us," said Rickland G. Asai, DMD, chair of the Grant Committee. "We receive more grant requests than we are able to fund, and choosing among them is a challenge. We try to look at the impact our funds will have on a community, the level of local support and whether or not an effective program would continue without our support. As our foundation corpus continues to grow, we look forward to the ability to fund more of these deserving applicants."

"More than half of Oregon children suffer from tooth decay, and underprivileged children are at greater risk,"

stated ODF President Kenneth R. Berg, DMD. "With ODF's help, many low-cost dental programs have been able to deliver needed care. The fall grants helped fund programs for children and adults. Treatment, education and alleviation of pain are goals of our grants. Fortunately, dentists throughout the state are generous with donations of their time and money."

Grant applications for the spring grant cycle will be accepted March 1–15, 2006. Spring grants will be awarded in June. ODF Seeks Nominations for Volunteer Awards

The Oregon Dental Foundation (ODF) is accepting nominations now through **April 15, 2006**, for its annual Awards of Excellence. Awards will be given in three categories:

Outstanding Dental Program Achievement

A community dental clinic or dental education program that has previously received an ODF grant is eligible. The winner must demonstrate innovation and creativity in the design or delivery of service. This year's recipient was the Beaverton Rotary's Dental Check/Dental Aid program.

Volunteer Dentist of the Year

Dentists who actively volunteer in a community dental clinic or nonprofit organization that has received a past

ODF grant are eligible. The winner will be recognized for compassion, long-term service and volunteerism. This year's recipient was Dr. David Doyle.

Healing Hands Award

Dental hygienists, assistants or front office staff who volunteer their services to a community dental program or clinic are eligible. The award winner will be recognized for long tenure, excellent professional skills and selfless service.

Dental Offices, Individuals Raise \$30,000 as Part of *Give a Day for Dentistry*
